**SUBJECT:** SCP trade 3<sup>rd</sup> quarter 2018/19

## Summary

Through the third quarter of 2018/19, net imports of sugar in products continued to grow - up 48,231 strv 6.5% over net imports through the third quarter of 2017/18. Imports of sugar in SCPs are up 3.7%, 49,430 strv compared to 2017/18. Exports have increased modestly, 0.2%, 1,199 strv.

A 7% increase in net imports for the year would be about 72,000 strv, which would contribute to flat domestic disappearance in USDA's normal sugar balance framework. For the first eight months of 2018/19, the Sweetener Market Data report showed total deliveries up 0.9% while the May WASDE report projects a 0.5% increase.

### **Exports**

Exports of sugar in SCPs increased modestly through the third quarter, up 0.2% compared 2017/18. Exports were previously up 1% in the second quarter of 2018/19 relative to 2017/18. This is the third straight quarter of growth after exports decreased continually from April 2015/16 to the end of 2017/18.

Exports of sugar in SCPs were up for Chapters 19, 21, and 22. They were down in Chapters 17, 18 and 20. Exports of SCP's in Chapter 17 were down 4.6% (6,682 strv) through the third quarter compared to 2017/18. There was a large drop in exports (4,824 srtv, 88%) of 1702904500 "Sugars and syrups, NESOI, derived from sugar cane/beets" to Mexico compared to exports in 2017/18. This continued a trend from the second quarter, where exports of this item relative to 17/18 were also down significantly. Chapter 18 exports were down 1.2% compared to exports through the third quarter of 2017/18. Chapter 19 exports were up 4.9%, 6,686 strv, through the third quarter compared to 2017/18. The increase in Chapter 19 exports made up 80% of the increase in overall exports, continuing the trend from the second quarter. Exports of sugar in SCPs in Chapter 20 fell 5.6% (726 strv). Exports in Chapter 21 are up 0.9% (875 strv) and exports in Chapter 22 are up 0.1% (33 strv).

Exports of sugar in SCPs to Canada fell 0.4% (1,265 strv) through the third quarter compared to 17/18. Exports to Mexico increased 2.3% (1,833 strv). Exports to the rest of the world (ROW) increased 0.3% (632 strv).

Canada leads the US export destinations of sugar in products and accounted for about 47.4% of sugar exports in SCPs through the third quarter of 2018/19. Mexico accounted for 13.6%. The rest of the world received the balance, 39%.

## **Imports**

Total imports of sugar in SCPs continued to rise and are up 3.7% (49,430 strv) through the third quarter of 2018/19.


Imports of sugar increased in all categories except for Chapters 17 & 22. Imports of sugar in SCPs in Chapter 17 were roughly equivalent, down less than 1%, 210 strv, through the third quarter of 2018/19 compared to 2017/18. Imports in Chapter 18 increased 6.3%, 18,655 strv. The imports of 1806208300 (COCOA PREPERATIONS, BULK, DAIRY PRODUCTS IN US NOTE 1, OTHER) have more than doubled compared to imports through the third quarter of 2017/18. Chapter 19 imports of sugar in SCPs increased 8.9%, 24,065 strv, through the third quarter of 2018/19. Imports in Chapter 20 were up 7.5%, or 3,857 strv. Chapter 21 imports grew 6.3%, 8,618 strv. Imports in Chapter 22 were down 3.3%, 5,556 strv, compared to 2017/18.

Imports of sugar in SCPs from Canada increased 2.6%, 11,422 strv, compared to 2017/18. Imports from Mexico were up 5.8% or 25,790 strv. Imports of sugar in SCPs from the ROW grew 2.6%, an increase of 12,218 strv.


### Net imports

Net imports of sugar in products through the third quarter of 2018/19 totaled 792,467 strv, up 48,321 strv or 6.5% over 2017/18.

Net imports of sugar in SCPs from Canada through the third quarter of 2018/19 were up 8.6%, 12,688 strv compared to 2017/18. Net imports from Mexico are up 6.6% or 23,957 strv, and net imports of sugar in SCPs from the ROW are up 5%, 11,586 strv.
