SUBJECT: SCP trade 4th guarter 2018/19

Summary

The volume of sugar in imported SCP's is up again through the fourth quarter of 2018/19. Imports of SCPs for the marketing year hit an all-time high of 1,910,144 strv, a 4% increase over 2017/18. Exports for the 2018/19 market year were 811,851 strv, down slightly, by 0.06%, compared to the previous market year.

Net imports of sugar in products once again exceeded one million tons this marketing year. In 2017/18 imports of SCPs totaled 1,030,859 strv. In the fourth quarter of 2018/19, net imports of sugar in products continued to grow strongly and ended the market year at 1,098,293 strv, up 67,434 strv or 6.5% over the 2017/18 market year.

This sugar represents additional domestic consumption on top of what is shown in USDA's formal supply-demand balance. In the October 10 WASDE report, total domestic deliveries were estimated to be down from two years ago, indicating declining per capita consumption. The growth in imports of sugar containing products, while strong, has not been enough to hold per capita disappearance steady. Given the big gap between US and world sugar prices, net imports of sugar in SCPs could continue to rise in 2019/20, keeping a lid on domestic sugar deliveries.

Exports

Exports of sugar in SCP's are down slightly through the fourth quarter of 2018/19, ending the year down 0.1%, or 487 strv, compared to 2017/18. Exports began slowing in the April-June quarter of 2015/16 when exports fell by a small amount and fell every quarter until the end of 2017/18. Exports recovered through the first three quarters in 2018/19, but ultimately ended the year down. Exports have fallen every year since the 2015/16 market year.

Exports of sugar in SCPs were up for Chapters 19, 21, and 22. They were down in Chapters 17, 18 and 20. Exports of SCP's in Chapter 17 were down 4.4% (8,456 strv) at the end of the fourth quarter compared to 2017/18. Exports of 1702904500 "Sugars and syrups, NESOI, derived from sugar cane/beets" to Mexico are down for the year (4,785 srtv, 84%) compared to exports in

2017/18. The decrease in exports of 1702904500 "Sugars and syrups, NESOI, derived from sugar cane/beets" comprised 65% of the total decrease in exports for the year. Chapter 18 exports were down 0.8% compared to exports at the end of the fourth quarter of 2017/18. Chapter 19 exports were up 3.2%, or 8,232 strv, through the fourth quarter compared to 2017/18. The increase in Chapter 19 exports made up 80% of the increase in overall exports, for the year. Exports of sugar in SCPs in Chapter 20 fell 3.7% (645 strv). Exports in Chapter 21 are up 1.2% (1,615 strv) and exports in Chapter 22 are up 0.6% (232 strv).

Exports of sugar in SCPs to Canada fell 0.9% (3,599 strv) at the end of the year compared to 17/18. Exports to Mexico increased 2.7% (2,932 strv). Exports to the rest of the world (ROW) increased 0.1% (180 strv).

Canada leads the US export destinations of sugar in products and accounted for about 47.4% of sugar exports in SCPs in 2018/19. Mexico accounted for 13.7%. The rest of the world received the balance, 38.8%.

Imports

Total imports of sugar in SCPs continued to rise through the fourth quarter of 2018/19. Imports of sugar in SCPs ended the year up 3.6%, 66,946 strv, through the fourth quarter.


Imports of sugar increased in all categories except for Chapter 22. Imports of sugar in SCPs in Chapter 17 were up 0.2%, 1,250 strv, through the fourth quarter of 2018/19 compared to 2017/18. Imports in Chapter 18 increased 6.6%, or 26,631 strv. The imports of 1806208300 (COCOA PREPERATIONS, BULK, DAIRY PRODUCTS IN US NOTE 1, OTHER) have nearly doubled compared 2017/18 import levels. Chapter 19 imports of sugar in SCPs increased 8.5%, by 31,306 strv, through the fourth quarter of 2018/19. Imports in Chapter 20 were up 6.5%, or 4,511 strv. Chapter 21 imports grew 3.5%, 6,812 strv. Imports in Chapter 22 were down 1.5%, by 3,564 strv, compared to 2017/18.

Imports of sugar in SCPs from Canada increased 2.4%, by 14,324 strv, compared to 2017/18. Imports from Mexico were up 5.1% or 31,050 strv. Imports of sugar in SCPs from the ROW grew 3.4%, an increase of 21,572 strv.


Net imports

Net imports of sugar in products through the fourth quarter of 2018/19 totaled 1,098,293 strv, up 67,434 strv or 6.5% over 2017/18.

Net imports of sugar in SCPs from Canada in 2018/19 were up 8.6%, by 17,923 strv, compared to 2017/18. Net imports from Mexico are up 5.7% or 28,393 strv, and net imports of sugar in SCPs from the ROW are up 6.6%, by 21,393 strv.
