**SUBJECT:** SCP trade 1<sup>st</sup> quarter 2019/20

## Summary

In the first quarter of 2019/20, net imports of sugar in products continued to grow - up 15,650 strv, 6.2% over the first quarter of 2018/19. Imports of sugar in SCPs are up 2.9%, 13,458 strv compared to the first quarter of 2018-19. Exports have decreased slightly, 1.1%, 2,192 strv.

A 6.2% increase for the year would be about 62,600 strv, which would contribute to flat domestic disappearance in USDA's normal sugar balance framework. For the first three months of 2019/20, the Sweetener Market Data report showed total deliveries down 2.9% while the January WASDE report projects a 1,000 strv decrease.

## **Exports**

Exports of sugar in SCPs were relatively stable, decreasing 1.1% compared to the first quarter of 2018/19. Exports finished down 0.1% through the 4<sup>th</sup> quarter of 2018/19. This continued a four year trend of overall exports decreasing.

Exports of sugar in SCPs were up for Chapters 19 and 20. They were down in Chapters 17, 18, 21, and 22. Exports of SCP's in Chapter 17 were down 2.6% (1,234 strv) in the first quarter compared to 2018/19. Chapter 18 exports were down 2.2% compared to the first quarter in 2018/19. Chapter 19 exports were up 1.5%, 978 strv, in the first quarter compared to 2018/19. Exports of sugar in sugar-containing products in Chapter 20 increased 3.3% (143 strv). Exports of products in Chapter 21 are down 0.9% (271 strv) and exports in Chapter 22 are down 7.6% (784 strv).

Exports of sugar in SCPs to Canada decreased 0.1% (65 strv) in the first quarter. Exports to Mexico increased 6.5% (1,916 strv). Exports to the rest of the world (ROW) decreased 4.8% (4,043 strv).

Canada leads the US export destinations of sugar in products and accounted for about 46.1% of sugar exports in SCPs in the first quarter of 2019/20. Mexico accounted for 15.2%. The rest of the world receives the balance, 38.7%.

# **Imports**

Total imports of sugar in SCPs continued to rise and are up 2.9% (13,458 strv) in the first quarter of 2019/20 compared to 2018/19.


Imports of sugar increased in Chapters 17, 18, and 21. Imports of sugar decreased in Chapters 19, 20, and 22. Imports of sugar in SCPs in Chapter 17 grew 7.2%, 10,121 strv, in the first quarter of 2019/20 compared to 2018/19. Increases in imports of 1704903550 CONFECTIONS READY FOR CONSUMPTION, RETAIL SALE, OTHER, made up the majority of the increase in Chapter 17 imports, with an additional 6,661 strv being imported over Q1 2018/19 imports. Imports in Chapter 18 increased modestly, 0.1% or 145 strv. Chapter 19 imports of sugar in SCPs decreased 72 strv, 0.1% in the first quarter of 2019/20. Imports in Chapter 20 were down 6.2%, or 1,118 strv. Chapter 21 imports grew 19.5%, 7,907 strv. Imports in Chapter 22 were down 6.5%, 3,525 strv, compared to 2018/19.

Imports of sugar in SCPs from Canada grew 7.2%, 10,719 strv, compared to 2018/19. Imports from Mexico were down 0.9% or 1,300 strv. Imports of sugar in SCPs from the ROW grew 2.4%, an increase of 4,039 strv.


#### Net imports

Net imports of sugar in products in the first quarter of 2019/20 totaled 269,436 strv, up 15,650 strv or roughly 6.2% over 2018/19.

Net imports of sugar in SCPs from Canada in 2019/20 were up 20%, 10,784 strv compared to the first quarter 2018/19. Net imports from Mexico are down 2.7% or 3,217 strv, and net imports of sugar in SCPs from the ROW are up 9.9%, 8,083 strv.
