SUBJECT: SCP trade 2nd quarter 2019/20

Summary

Through the second quarter of 2019/20, net imports of sugar in products continued to grow - up 29,485 strv, 5.8%, over net imports through the second quarter of 2018/19. Imports of sugar in SCPs are up 2.5%, 22,546 strv compared to 2018/19. Exports have decreased 1.7%, 6,939 strv.

A 5.8% increase in net imports for the year would be about 63,740 strv, which would contribute to flat domestic disappearance in USDA's normal sugar balance framework. For the first six months of 2019/20, the Sweetener Market Data report showed total deliveries up 2.9 percent, while the April WASDE report projects a 1,000 strv decrease compared to 2018/19.

Exports

Exports of sugar in SCPs decreased through the second quarter, down 1.7% compared to the second quarter of 2018/19.

Exports of sugar in SCPs were up for Chapters 19 and 20. They were down in Chapters 17, 18, 21, and 22. Exports of sugar in SCP's in Chapter 17 were down 3.6% (3,369 strv) through the second quarter compared to 2018/19. Exports of 1704907000, SUGAR CONFECTIONERY, WITHOUT COCOA, NESOI, to Canada dropped 15.4%, 2,081 strv compared to the second quarter of 2018/19. Chapter 18 exports were down 3.3% compared to exports through the second quarter of 2018/19. Chapter 19 exports were up 0.5%, 615 strv, through the second quarter compared to 2018/19. Exports of sugar in SCPs in Chapter 20 increased 6.9% (566 strv). Exports of sugar in SCPs are down 2.3% for both Chapter 21 and Chapter 22 (1,455 and 463 strv, respectively).

Exports of sugar in SCPs to Canada decreased 0.7% (1,374 strv) through the second quarter. Exports to Mexico increased 9.7% (5,291 strv). Exports to the rest of the world (ROW) decreased 6.8% (10,856 strv).

Canada leads US export destinations of sugar in products, accounting for about 47.4% of sugar exports in SCPs through the second quarter of 2019/20. Mexico accounted for 15.1%. The rest of the world receives the balance, 37.5%.

Imports

Total imports of sugar in SCPs continued to rise and are up 2.5% (22,546 strv) through second quarter of 2019/20.

Imports of sugar increased in all categories except for Chapter 22. Imports of sugar in SCPs in Chapter 17 grew 3.3%, 9,080 strv, through the second quarter of 2019/20 compared to 2018/19. Imports of 1704903550, CONFECTIONS READY FOR CONSUMPTION, RETAIL SALE, OTHER, increased 6.4%, 11,819 strv, accounted for 88% of the increase of Chapter 17 imports. Chapter 18 imports increased 1.7%, 3,514 strv. Chapter 19 imports of sugar in SCPs increased 0.9%, 1,774 strv, through the second quarter of 2019/20. Imports in Chapter 20 were up 1.3%, or 448 strv. Chapter 21 imports grew 11.1%, 9,712 strv. The increase in Chapter 21 imports was driven by a 48 percent (6,526 strv) increase in imports of 2101205400, TEA/MATE PREPS, >10% SUGAR NOTE3-CH17, NOTE8-CH17. Imports in Chapter 22 were down 1.9%, 1,983 strv, compared to 2018/19.

Imports of sugar in SCPs from Canada increased 6.3%, 18,424 strv, compared to 2018/19. Imports from Mexico were down 1.8% or 5,359 strv. Imports of sugar in SCPs from the ROW grew 3.0%, an increase of 9,481 strv.


Net imports

Net imports of sugar in products through the second quarter of 2019/20 (year-to-date) totaled 538,332 strv, up 29,485 strv or 5.8% over 2018/19.

Net imports of sugar in SCPs from Canada through the second quarter of 2019/20 were up 19.2%, 19,797 strv compared to 2018/19. Net imports from Mexico were down 4.2% or 10,650 strv, and net imports of sugar in SCPs from the ROW are up 13.2%, 20,337 strv.
