Summary

The volume of sugar in imported SCP's is up again through the fourth quarter of 2019/20. Imports of SCPs for the marketing year hit an all-time high of 1,938,899 strv, a 1.3% increase over 2018/19. Exports for the 2019/20 market year were down 768,036 strv, 6.1%, compared to the previous market year.

Net imports of sugar in products once again exceeded one million tons this marketing year. In 2018/19 imports of SCPs totaled 1,095,572 strv. In the fourth quarter of 2019/20, net imports of sugar in products continued to grow strongly and ended the market year at 1,170,863 strv, up 75,291 strv or 6.9% over the 2018/19 market year.

This sugar represents additional domestic consumption on top of what is shown in USDA's formal supply-demand balance. In the October WASDE report, total domestic deliveries were estimated to have increased compared to last year, indicating a slight increase in per capita consumption. The strong growth in imports of sugar containing products has been enough to hold per capita disappearance steady. The Sweetener Market Data report also has total domestic deliveries up 2% relative to 2018/19.

Exports

Exports of sugar in SCP's are down through the fourth quarter of 2019/20, ending the year down 6.1%, or 50,122 strv, compared to 2018/19. Exports began slowing in the April-June quarter of 2015/16 when exports fell by a small amount and fell every quarter until the end of 2017/18. Exports recovered through the first three quarters in 2018/19, but ultimately ended the year down. Exports were consistently down at least 5% throughout the 2019/20 marketing year compared to 2018/19.

Exports of sugar in SCPs were up for Chapters 19 and 20. They were down in Chapters 17, 18 and 21, and 22. Exports of SCP's in Chapter 17 were down 9.4% (17,337 strv) at the end of the fourth quarter compared to 2018/19. Specifically, exports of 1704903000, CONFECTIONS

/SWEETMEATS, READY FR CONSUMPTN, NO COC finished the year down 13 percent, 8,536 strv. Chapter 18 exports were down 12.2%, 21,864 strv compared to exports at the end of the fourth quarter of 2018/19, with exports of 1806900073 COCOA PREPS EXCEPT CONFECTIONERY NESOI, FOR RETAIL having fallen 6,807 strv, a 22% decrease. Exports of Chapter 19 exports were up 0.1%, or 252 strv, through the fourth quarter compared to 2018/19. Exports of sugar in SCPs in Chapter 20 increased 6.3% (1,038 strv). Exports in Chapter 21 are down 8.8% (11,886 strv) and exports in Chapter 22 are down modestly, 0.8% (324 strv).

Exports of sugar in SCPs to Canada increased 0.1% (227 strv) at the end of the year compared to 2018/19. Exports to Mexico increased 0.8% (935 strv). Exports to the rest of the world (ROW) decreased 16% (51,284 strv).

Canada leads the US export destinations of sugar in products and accounted for about 50.4% of sugar exports in SCPs in 2019/20. Mexico accounted for 14.7%. The rest of the world received the balance, 34.9%.

Imports

Total imports of sugar in SCPs continued to rise through the fourth quarter of 2019/20. Imports of sugar in SCPs ended the year up 1.3%, 25,169 strv, through the fourth quarter.


Imports of sugar increased in all categories except for Chapter 18. Imports of sugar in SCPs in Chapter 17 were up 0.4%, 2,534 strv, through the fourth quarter of 2019/20 compared to 2018/19. Imports in Chapter 18 decreased 2.7%, or 11,581 strv. Imports of 1806105500 COCOA POWDER, SWEETND, > 90% SUGAR, >65% SUGAR,NOTE 2, OTHER fell 21 percent, 15,523 strv compared to 2018/19. Imports of Chapter 19 sugar in SCPs increased 1.9%, by 7,780 strv, through the fourth quarter of 2019/20. Imports in Chapter 20 were up 12.3%, or 9,110 strv. Chapter 21 imports grew 5.7%, 11,366 strv. Imports in Chapter 22 were down 2.6%, by 5,959 strv, compared to 2018/19.


Imports of sugar in SCPs from Canada increased 2.14%, by 12,559 strv, compared to 2018/19. Imports from Mexico were down 1.4% or 8,815 strv. Imports of sugar in SCPs from the ROW grew 3.2%, an increase of 21,425 strv.

Net imports

Net imports of sugar in products through the fourth quarter of 2019/20 totaled 1,170,863 strv, up 75,291 strv or 6.9% over 2018/19.

Net imports of sugar in SCPs from Canada in 2019/20 were up 5.5%, by 12,332 strv, compared to 2018/19. Net imports from Mexico are down 1.9% or 9,750 strv, and net imports of sugar in SCPs from the ROW are up 21%, by 72,209 strv.
